Apex: Primary fundraiser of the year, this was expected to be the replacement of the auction. On October 31st the need to have a care room from covid is completely gone. It would be great to be really really organized prior to November $1^{\text {st }}$. If $6^{\text {th }}$ grade moves to middle school next year, we will get a room next year.
- Spirit Wear: we have a spirit wear sale going on until September $18^{\text {th }}$, but its been a little slow
- Membership: getting everything qued up right now.
- Fundraiser: we are going to do at least on catalogue sale, hopefully around the holiday season. We want to get people involved at the community level.
- Grizzley Reader: what is our committee budget: Christy will send it out at the end of the night, but it is not officially approved until voted in at the first general membership meeting. Anything that is not colored can be done at school.
- Holiday Grams - we would love someone to do holiday grams! Christy can do it with someone, but she can't do it by herself. It would be great for a couple of friends to run it together! We won't be able to do it during valentines day this year due to Apex and Valentine's Day being during winter break. Or we could do lucky charm grams with a gold coin and green paper.
